

that the self respect and dignity of the individual beneficiary is not adversely affected. For this reason any public distribution of study assistance must be avoided, though the contrary may help fund raising.

- (iv) To help individuals and families, especially, the aged and the sick, the children and the widows, according to each one's needs.
- (v) To establish and promote programs and projects to better the abject living conditions of the poor and homeless, irrespective of their caste or creed or geographical situation. To provide the bare necessities of life like food, clothing, shelter etc.
- (vi) To assist with genuine compassion the seriously sick destitute people to have suitable care and cure. To promote palliative care of the incurable, especially of cancer and aids, which is far beyond the capacity of the poor.
- (vii) To promote pure and healthy drinking water to the rural folks, the absence of which is the root cause of many serious health problem in our villages.
- (viii) To organize general medical camps, eye camps, diagnostic camps for cancer and aids, immunization and vaccination camps and to supply preventive medicine.
- (ix) To promote the donation of blood to save lives in critical cases. It is a service which practically does not exist in our rural and semi-rural areas of our country.



5. FUND RAISING:-



7. BOARD OF TRUSTEES:-

The Board of Trustees shall consist of 3 members,

The Chairman/Managing Trustee, Secretary, Treasurer. The Author nominated the Trustees and has constituted the Board of Trustees.



The Trust Board shall meet at least once in 6 months, on a date and at a place notified by the Chairman for taking necessary decisions and for reviewing the activities of the Trust. The presence of 2/3 members shall form the required quorum for any meeting of the Trust provided all the trustees are called for. The minutes of the proceedings of every meeting of the Trustees shall be entered in a book to be kept for that purpose, and it shall be signed by the Chairman and the Secretary, and it shall be the conclusive evidence of all matters dealt with at such meetings.


8. DUTIES AND POWERS OF THE BOARD OF TRUSTEES:-

At the beginning of the financial year, taking into account the amount available for charities during the current financial year, the Trust Board prepares and approves a provisional budget of expenditures to be incurred and fixes the maximum amount of assistance payable to a single individual or family.

9. THE CHAIRMAN/MANAGING TRUSTEE:-

The Chairman has the responsibility of making prudent and wise investments of the funds of the Trust. He may purchase, take on lease, or otherwise acquire in any other legal manner both movable and immovable properties,

for the Trust at any time or place as he thinks fit. However to sell or alienate permanently any immovable property of the Trust he requires the consent of the Trustees.

The Chairman of the Trust shall hold office for life, until he resigns or becomes incapacitated or is legally removed from office. He will be the ultimate authority in the Trust. He shall preside over all the meetings of the Trust. He shall have a casting vote in case of a tie arises in the meetings. He will appoint, dismiss, suspend or otherwise punish any salaried employee of the Trust. He will be the Chief supervisor and ultimate controlling officer of the Trust. He will receive, in the name of the Trust, donations, and grants of all types, movable or immovable, anywhere in India or abroad. The Chairman maintain the documents of the immovable properties.

As Chairman/Managing Trustee, he has the executive powers to carry out the day to day administrative functions of the Trust. He can open Accounts for the Trust, deposit the funds of the Trust in any Bank's or organizations on behalf of the Trust. He dispenses all charities according to the norms of the Trust, to the eligible beneficiaries, and he overseas all works of charity directly or indirectly administered by the Trust. He is the legal representative of the Trust in all matters, who may sue or be sued on behalf of the Trust. As head of administration he has the responsibility to apply for and acquire all permits and licenses necessary to carry out the works of the Trust, which includes also permission from FCRA/FCMA to receive funds from abroad.

The secretary has the responsibility of maintaining all records of the Trust, such as documents of the properties, permits and licences possessed, minutes of the Board Meetings, copies of all correspondence etc., at the direction of the Chairman. He will also attend to any other duties as per the directions of the Chairman. In case the office of the Chairman unexpectedly falls vacant, he automatically becomes the new Chairman and runs the Trust, with all the rights and duties of the Chairman.

Treasurer:-

He transacts all financial matters under the guidance of the Chairman. He administers money matters in collaboration with the Chairman, in accordance with the norms of the Trust. On his own he can not dispose of any money belonging to the Trust. He maintains all accounts and has the responsibility of preparing the annual financial report for auditing as well as for presentation to the Governing Board as well as to all others concerned.

10. VACATION OF THE OFFICE OF TRUSTEES:-

A person shall cease to be a Trustee in any of the following manner:-

- a) If he dies
- b) If he resigns
- c) If he acts in contravention of the objects of the Trust, or in a manner detrimental to the interests of the Trust, or is deemed guilty of misconduct in the opinion of the rest of the Trust Board.

11. ACCOUNTS & AUDIT:-

The Chairman shall see to it that the treasurer maintains correct account of all monies received and spent in any manner for the purpose of the Trust and a balance sheet of such accounts is prepared at the end of the financial year which shall be audited and certified by a qualified Chartered Accountant appointed for that purpose. All transactions connected with the receipts and payments relating to the Trust shall be done in the name of the Trust only.

12. BANK ACCOUNTS:-

The Trust may open such Current, Savings, and fixed Deposit Accounts in the name of the Trust with such bank's as the Board may, from time to time, decide in this behalf to deposit the funds of the Trust. Any such account's shall be operated by the Chairman individually or the Chairman and the Treasurer jointly. Interest accruing from the "Corpus Fund" and incomes from any other sources only can be utilized for the day to day activities of the Trust. The Corpus Fund itself shall remain untouched.

13. TAKING OVER AND MANAGEMENT OF OTHER SIMILAR TRUSTS OR INSTITUTIONS:-

The Chairman, with the consent of the Board, may take over the ownership and management of other Trusts and Institutions whose objects are fully or in part similar to those of this Trust.

He shall have full powers to institute suits, claims or other proceedings and to compromise or compound all actions, suits and other proceedings and to settle differences and disputes concerning the properties of the Trust, and to adjust and settle all accounts relating to the Trust properties.


16. AMENDMENTS:-


